3. CEO Summary

Year End Report:

Loretta gave an extensive year-end report of the Girl Scout fiscal year ending September 30, 2023. She highlighted council successes in membership, exceeding our membership goals and also exceeding our Fund Development goals, topping it off with a successful Gala in September. Loretta also highlighted brining back Resident Camp to Camp Torqua over the summer and reported it was a success and will be bigger and better next summer. The Council also shared Product Program success with their Fall sale and Cookie sale for the year of 2022-2023. Big Improvements and updates to existing buildings were also made at Camp Torqua to increase camp capacity by over 50%. Topping off the successful year, the Council was awarded a 3-year charter by GSUSA.

Operations Update

Jess Upchurch, COO, gave an update on operations. Membership update, currently 5769 girls – 87% to goal, 3200 adults which is 115% of our adult goal.

Fall Festival at Camp Torqua was a huge success again this year, 329 members attended. Older Girl/Higher Awards Overnight at Camp Torqua – 41 girls attended, also a big success, hard to retain older girls. Other highlights - 147 attended Cookie Biz Bash & 27 girls attended Space Camp

One other note from Council coming from GSUSA – no increase in membership dues for 2024/2025

	The deficit is mostly made up of: product program, staffing not budgeted, and interest				
	paid on the line of credit was much higher because of interest rates.				
	As of end of October 2023, new budget year which consists of a positive variance of				
	\$8000. With only one month into the fiscal year, differences to budget are made up of				
	retail increase (had a great month), landscaping refresh was paid for by a sale of the				
	mobile truck. Total net revenue/expenses were a deficit of \$30,000.				
	Ron Buerges, CFO reported the new budget looks great, finance department did an				
excellent job. The line of credit was paid down by \$550,000 paid for by Chen					
	Funds – borrowing from ourselves. These funds will be paid back first.
