Line of credit – interest expense is over budget. Council started using LOC in June.

Finance Dept. is working with Commerce to move interest and dividends from investments transferred to the operating account

Camp Torqua Mowers

Finance Committee has already approved this and discussed it at length.

6. Property Task Force - Steve Bushong

- Property Updates
 - Camp Torqua Updates new shower house is complete, just in time for camp season. ADA grant option up to \$100,000/year, looking at a handicap trail paved. We are seeking funding for help with building the lake, staff is seeking help from Corp of Engineers with planning. Council would like to be able to get approval to seek out information to how much a lake would cost us and how they can get help in building the lake through funders.
