1. Girl Scouts of Southern Illinois will cooperate with the bank, support the procedures, and will take action to ensure that each account is maintained in a responsible manner.
2. The Girl Scouts of Southern Illinois shall have access to records of each Girl Scout account.
3. The Girl Scouts of Southern Illinois shall have the authority to close any Girl Scout account.
4. Girl Scout accounts may have a one debit card per troop but not have cash withdrawal or cash advance access.
5. Girl Scout accounts may have online access for viewing purposes ONLY.
