An ex-officio member can give input to policies and other governance matters, but does not have a vote. This position provides a great leadership opportunity for girls who would like to be more involved in high level decision making. All interested girls must complete this form and follow the submission instructions at the bottom of the application.

Applicant Requirements:

1. Must be a registered member of Girl Scouts.
2. Must be 14 years of age or older by the application deadline, January 30, 2019.
3. Must be willing to meet, in-person or via conference call for at least 90% of board meetings (6 total board meetings in 2019), attend regional delegate meetings, and attend the council's Annual Meeting on Saturday, April 27, 2019 in Ina, IL at Rend Lake College.
4. Must attend a teleconference interview with the Board Development Committee on February 11, 2019.
